§1

GENERAL PROVISIONS

§2

DEFINITIONS

- 1. **REGULATIONS** these Terms of the Promotion, including the duration of the Promotion, rules of the Promotion, the rules for making refunds and the rules of the complaint procedure.
- 2. **ORGANIZER** OstroVit sp. z o.o.
- PARTICIPANT a natural person with legal capacity who has accepted the terms of these Regulations.
- 4. **ONLINE STORE** the online store run by the Organizer at <u>www.ostrovit.com</u> and <u>ostrovit.de</u>, where the promotion is organized.
- 5. **PROMOTION** a special, time-limited offer that reduces the price of the Products when they are purchased.
- 6. **DISCOUNT** an amount or percentage discount on Products available in the Online Store.
- PRODUCT a movable item purchased by the Customer through the Online Store under a Sales Agreement.
- RABAT CODE an electronic discount code entitling the Promotion Participant to redeem it in the Online Shop www.ostrovit.com or www.ostrovit.de, in the form of a percentage or amount discount calculated on the value of the order.

PROMOTION TERMS

- 1. Participation in the Promotion is voluntary.
- 2. Participation in the Promotion is tantamount to reading and accepting these Regulations.
- 3. The promotion addressed to customers of the Online Store.

RESCISSION

- In the case of rescission from the contract, the Participant is obliged to return the Products undamaged and without signs of use Products purchased as part of the Promotion within 14 days of receiving the Products.
- 4. Returned Products should be delivered in original and undamaged packaging.
